1. Owner agrees to pay the rate for pet care provided in effect on the date pet is checked into the Facility.
2. Owner agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the period said pet is in the care of the Facility.
3. Owner agrees that the pet shall not leave the facility until all charges are paid to the Facility
4. Owner consents to Facility using pet's likeness and waiver all claims of compensation for use of such likeness by the Facility.
5. By signing this Contract and leaving pet with Facility, Owner certifies to the accuracy of all information given about the pet.
6. Facility shall exercise reasonable care for the pet delivered by the Owner to Facility. Owner recognizes and accepts potential risks involved with pet grooming. It is expressly agreed by Owner and Facility that Facility's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$500.00 per animal admitted.
7. Owner agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of Facility, and assume any expense and liability for injury to any human or other animals or damage to the facilities caused by the pet.
8. Owner specifically represents to Facility that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.

9. Owner specifically represents to Facility that, to Owner's knowledge, the pet has not been exposed to any contagious disease within a thirty-day period prior to check-in. During the period of this Agreement. Owner also agrees to notify Facility of any known exposure of pet to a communicable disease and hold pet to of attending
10. All charges incurred by owner shall be payable upon pick-up of pet. Facility shall have, and is hereby granted a lien on the pet for any and all unpaid charges resulting from services provided by Facility.
11. If pet becomes ill or injured or if the state of the animal's health otherwise requires professional attention. Facility, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention
12. This contract contains the entire agreement between the parties. All terms and conditions of this agreement shall be binding on the heirs, administration, personal representatives and assigns of the Owner and Facility.
13. Any controversy or claim arising out of or relating to this Agreement, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this agreement, shall be settled in accordance with the rules of the American arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitration and reasonable attorney's fees of the prevailing party.
14. If pet receives more than 14 days of service from facility, then the facility may require a portion of the charges incurred to be paid prior to pick up(release) of pet.
